ARBITRAL AWARD

After hearing the parties on Friday, June 15, 2007, I find the following facts:

1. On August 30, 2004, Plaintiff Peter J. Najdzion was the operator of a 1992 Honda Acura facing in a general easterly direction on Cedar Street in Newington, CT and was stopped for traffic in the right hand lane.

2. Defendant Danielle Demar was driving a 1997 Ford owned by Defendant Joann Demar behind Plaintiff Peter J. Najdzion.

3. Defendant Danielle Demar rear-ended Plaintiff Peter J. Najdzion while he was stopped at the traffic light.

4. The accident was sufficiently hard to bend the Acura's frame and total the car.

5. Liability is not contested. The main issue relates to the quantum of damages.

6. Plaintiff Peter J. Najdzion suffered the following damages because of Defendant Danielle Demar and Defendant Joann Demar's negligence:

Dr. Shifreen	\$420.00
lost wages	\$240.00
Total	\$7,035.00

7. Plaintiff Peter J. Najdzion did not seek emergency treatment, but went to a Modern Chiropractor on September 1, 2004.

8. Questions were raised about Plaintiff Peter J. Najdzion's ability to perform his job because of lasting effects of the accident.

9. While Plaintiff Peter J. Najdzion has trouble handling the heavier aspects of his job as an auto mechanic, he is able to do them with assistance. He has been promoted twice since the accident. While he only has a high school and trade school education, he is only 22 and obviously bright and talented.

10. I find no material impairment on Plaintiff Peter J. Najdzion's ability to make a living.

11. Plaintiff Peter J. Najdzion suffered damages amounting to \$26,000.00 because of Defendant Danielle Demar and Defendant Joann Demar's actions.

Judgment shall enter in favor of Plaintiff Peter J. Najdzion and against Defendant Danielle Demar and Defendant Joann Demar for \$26,000.00 plus costs to be taxed.
