ARBITRAL AWARD

- I, Houston Putnam Lowry, after hearing the parties on Friday, March 18, 2005, find the following:
- 1. For the purposes of this hearing only, Defendant Tracey Lattimore stipulates to liability.
- 2. On January 7, 2002, Defendant Tracey Lattimore struck the rear of Plaintiff's 2001 Nissan Pathfinder.

 Defendant Tracey Lattimore was driving a Mazda Protegé owned by Defendant Chase Manhattan Auto Finance Corporation.
- 3. At the time of impact, Plaintiff was turned and looking over her right shoulder.
- 4. The impact caused very little damage to the two cars. The damage to Plaintiff's car was \$210.68.

- 5. The police report indicated there was no visible damage to either car.
 - 6. Plaintiff's injuries are all soft tissue injuries.
- 7. While Plaintiff has treated extensively with bona fide doctors, Plaintiff has no permanent partial disability rating nor have her doctors been able to diagnose or effectively treat her symptoms.
- 8. Plaintiff Sandra Roldan incurred the following expenses because of Defendants' actions:
