ARBITRAL AWARD

After hearing the parties on Friday, June 26, 2009, I find the following facts:

1. On July 23, 2006 at approximately 5:40 P.M., Plaintiff Lorraine Walters owned and operated a 2000 GMC Denali Subaru Lagacy, bearing Connecticut registration 153 RKN and traveling in a westerly direction on Brown Street in Hartford, CT.
2. Plaintiff Leah Richard was a minor in Plaintiff Lorraine Walters' car.
3. At the same time, Defendant Jiaccone Rudolph, was operating a 1993 Jeep Wagoneer owned by Defendant Teresa Sharp, bearing Connecticut registration 974 SEP, and was traveling in a northerly direction on Franklin Avenue at its intersection with Brown Street in Hartford, Connecticut.

4. At all material times, Defendant Jiaccone Rudolph was operating the vehicle with the permission of the owner, Defendant Teresa Sharp.

5. At all material times, Franklin Avenue and Brown Street were public highways in the City of Hartford, Connecticut.

6. Defendant Jiaccone Rudolph failed to obey a red traffic signal, and crashed into Plaintiff Lorraine Walters' vehicle.

7. The parties continued north on Franklin Avenue when Defendant Jiaccone Rudolph sideswiped Plaintiff Lorraine Walters' vehicle, causing a second collision between the vehicles.

8. For the purposes of this arbitration only, Defendants admit liability.

9. Plaintiff Lorraine Walters sought treatment two days after the accident.

10. Plaintiff Lorraine Walters suffered \$6,000.00 in damages caused by Defendants, but suffered no permanent disability.

11. Plaintiff Leah Richard sought treatment one day after the accident.

12. Plaintiff Leah Richard suffered \$600.00 in damages caused by Defendants, but suffered no permanent disability.

Judgment shall enter in favor of Lorraine Walters against both Defendants for \$6,000.00. Judgment shall enter in favor of Leah Richard against both Defendants for \$600.00.
